Delivery of Purchased Goods

Czech Post

Balík Up to ruky - Delivery of the shipment directly into the hands of the addressee at the specified address.

The Cenné psaní service of Czech Post means delivery of the shipment in special packaging and under increased security measures exclusively into the addressee's own hands. The maximum weight of the shipment is 2 kg; at a higher weight, dispatch is divided into several shipments, or the Cenné psaní service is changed to Cenný balík. Delivery normally takes place on the next business day after the shipment is taken over by the carrier. If the value of the shipment is higher than the value which the carrier delivers directly to the address into the addressee's hands, the delivery person leaves a notice in the addressee's mailbox so that the addressee collects the shipment within the specified period at the designated post office. Likewise, in the event of unsuccessful delivery, the delivery person leaves a notice in the addressee's mailbox. The shipment is normally stored at the post office for 15 days. Both the sender and the addressee may extend the period for collecting the shipment from the standard 15 days to 30 days. Notification of shipment delivery also takes place by a text message (SMS), provided that a mobile telephone number has been supplied to the carrier. Delivery of Cenné psaní requires identification and the recipient's signature. If Cenné psaní cannot be delivered, it is returned to the sender.

UPS

Express Saver, Signature Required - Delivery of the shipment to an adult person at the designated address (with the Adult Signature Required service).

The UPS Express Saver service together with the additional Adult Signature Required service and Direct Delivery Only means that the shipment containing the goods is handed over to an adult person, i.e. it must not be handed over to a minor. UPS requires the recipient's signature. The shipment is delivered to the designated address stated on the shipping label. Delivery of shipments cannot be rescheduled and shipments may not be redirected to any other alternative address. The maximum weight of the shipment is 2 kg; at a higher weight, dispatch is divided into several shipments. UPS sends the addressee an e-mail with a link to shipment tracking. Delivery takes place on the next business day after the shipment is taken over by the carrier to almost all business areas in Europe. Delivery in the USA and to the main business areas in Canada takes place by the end of the second business day. If the addressee is not present at the address, two further delivery attempts are made (3 attempts in total). In the event of unsuccessful delivery, the delivery person leaves a notice (Delivery notice) in the addressee's mailbox with customer service contact details, and the addressee is also informed of the unsuccessful delivery by e-mail. If UPS is unable to deliver the shipment, it returns it to the sender.
